Wildcat Canyon Bridge – This is the Year!

First the project was delayed because of the COVID hiatus and then by the resulting supply chain issues. Then, because a soil test proved the location of the planned abutments was not stable enough, CPW's project lead engineer, Dmitry Tepo, needed to modify the original design drawings. He has now prepared final construction drawings and supporting documents. As another gotcha, the Water and Land Conservation grant that is a major funding source, is under the auspices of the Federal government. They required the project to use only American produced materials. This wasn't a problem for the main interlocking modules that will form the bridge but literally a problem in finding American made nuts and bolts. However, Dmitry worked with the grant administrator to reach a solution. All is well.

Per Dmitry, there are a couple of permitting steps left to wrap up in the next few weeks, mainly a sign off from Douglas County and the Corps of Engineers. If everything goes smoothly with permitting, we can advertise the project for bid in the beginning of February. From there, he's estimating about 6 months for bidding, contract award, submittal reviews, bridge manufacture, and shipping. That puts the start of construction some time in August. However, there are still a lot of supply chain and labor availability issues that could delay us. So, a conservative estimate for the start date is Fall 2023.

Though the start date is a ways away, Friends has begun planning for the Bridge Donor appreciation plaques, and the dedication Grand Opening and party. We're going to have one plaque housed in the Visitor Center and an all-weather plaque located at one of the bridge abutments. Letters have been sent to the contributors who donated enough to have a 'plank'. Trail Explorers can dedicate one plank; Wildcats, two planks; Pride of the Canyon, four planks. The plaque planks will vary in size. So far donors have chosen to inscribed their names and/or family names or quotes (all about benefits of nature so far). Once we get all the inscription info, we'll finalize the plaque designs. If you're interested in helping with this, please contact Friends at focwcsp@gmail.com.

Volunteer Naturalist Training on Again for 2023

Keep your eye on your email inbox, Volunteers. Ranger Rachel Chaffee will soon be sending out information about this year's Naturalist Training. It will be aimed at new volunteers and towards the 2020 class whose training got waylaid because of Covid-19. Current plans have Prospect Day scheduled for Saturday, Feb 4 in the morning. The first required class, Orientation, will begin that very afternoon for the prospects who want to become Castlewood Canyon Volunteer Naturalists. Rachel's email will include the class schedule and information for the 2020 class. This year, classes will be spread out from Feb through August rather than eight consecutive Saturdays so that, for example, Plants can take place when the wildflowers are blooming – no more recognizing trees in the winter! Newbies will give their final presentations in the form of a display they will staff somewhere along the trails on Dam Day instead of an indoor presentation. Each newbie will have a veteran volunteer at their side as a mentor who may know the answers to visitor questions that the newbie doesn't yet have the experience to answer.

Dick was an important player in the early years of Friends and the Volunteer Naturalist program at Castlewood Canyon State Park. Over seven years he served in every officer position on the Friends Board from Vice President to President to Secretary and Treasurer. An engineer and fine woodworker, his handiwork is still evident

in the Visitor Center. If you have a hiking stick, that started with Dick who fashioned them and applied the brands. As President of Friends following Dave Shipley, he resurrected the *Voice of the Canyon*, believing that members had to be kept up-to-date on Friends' activities and progress.

Memories of Richard Brandt Friends Founding Officer and Volunteer Naturalist Extraordinaire

Dick was my VP for much of the time after starting Friends of CCSP in 1997. He was a sounding board for me when I had ideas about growing the organization or dealing with the Colorado State government bureaucracies (since for most of his professional career he was associated with State and local government engineering organizations). I could always count on him to give me sound, unvarnished advice. Some thought he was too direct in his demeanor, but not me! He was just what I needed to help guide the organization in the early, formative years before the merger of State Parks with Wildlife Management. I trusted him to keep things going when I was out of pocket for one reason or another and when it came time after many years for me to propose a successor for President, I didn't have to look far—it was Dick. He graciously accepted and was elected unanimously by the Board. In the years that followed, he would ask me for advice or opinions from time to time and we maintained an ongoing relationship until his and his wife's health started to become problematic and he needed to step down. By then the Friends of CCSP was an established entity and the rest is history. Aside from his Friends position, he was a major Volunteer contributor to Castlewood Canyon State Park and its development. He was and will continue to be, be sorely missed.

News from the Top

Hello Castlewood Canyon Friends,

Here we are forging forward into 2023! It's so strange to me we're there already; it feels like we're living in the future.

We've already seen a few Keep Colorado Wild (KCW) passes come through our entrance. This is the \$29 Annual Pass preloaded onto Colorado motor vehicle registrations starting this year. It's too soon to tell how successful this program is going to be, but suffice to say it's going to be a game changer. I remain optimistic--with even 50% participation, Parks will be bringing in over twice the pass revenue we brought in through our peak year during the pandemic.

You may have noticed a large construction project occurring north of the Homestead. This is the staging area for the Cherry Creek trail construction, connecting the park and where the trail presently ends at Highway 86. Douglas County asked for permission to use this area and we granted it. They're required to rehab it when they're done; with the weeds we have over there I suspect it will be more pristine afterwards than it was before. I'm expecting them to be done before spring gets underway.

Our new vault restrooms at Juniper Rock, the West Side Trailhead, and at the Homestead lot have a contractor! Hopefully we'll see them installed this summer. They're going to be a huge improvement, especially at the increasingly busy Homestead lot. I've rented a porta potty there for the last few years, and it's been very popular.

On staffing, I'm expecting our full-time Ranger vacancy to be filled come January 2024. I've also, as you may know, put a new full-time Interpreter position on our 5 year plan. The benefits to such a person here can't be overstated, and I think it's long overdue that we have one. New positions are, of course, subject to a lengthy approval process--including the State Legislature signing off. I'm hoping we'll see it here in 2024, though more likely '25 or '26, but it fundamentally depends on what happens with the KCW pass. If we're rolling in money, then great, if not, then it may be some time yet.

Thank you, as always, for all that you do for our park and State. Take care and I hope to see you soon!

Castlewood Canyon Remembered by the Metzler Estate

Many of you may remember from Naturalist history classes that Bob Metzler was Margaret and Patrick Lucas' grandson. Ron Claussen spent many hours with Bob learning about his memories of the Lucas homestead and shedding light on the life Bob's mother, Mary Lucas, had during the early 1900s. Here's some information about Bob excerpted from his 2020 obituary:

Robert Franklin Metzler, born Sept. 5, 1923, passed away at his home in Idaho Springs, Colorado, July 6, 2020, at the age of 96. ... Bob was a cattle rancher, educator, artist, adventurer, developer, and philanthropist.

He began his career in education in 1944 as a teacher in a one-room school. He served as a principal and, in 1952, was elected County Superintendent of Douglas County Schools. Bob contemplated national opportunities, but in 1964 eager to advance his avant-garde ideas concerning individualized learning, he accepted the position as Superintendent of Schools for Clear Creek County, where he campaigned to innovate and improve education. His success attracted the attention of the Ford Foundation and, with a team from Columbia University, presented his ideas at the 1964 World's Fair. ... Bob and his sister Rosemary developed a passion for reading and teaching from their mother, Mary, who was one of the few women of her time to attain a high school education.

His estate owned the water rights under the Lucas Homestead. The estate's wish was to sell the water rights and endow Friends of Castlewood Canyon with the proceeds. CPW, of course, did not want the rights, valued at \$300,000, to go to someone who would then encroach on the park to take advantage of the water. So CPW negotiated with the estate and ended up purchasing the rights for \$150,000. The estate, in turn, bequeathed the funds to Friends. The Metzlers clearly wanted the funds to be used in a way that would benefit children's environmental education. Until Friends and CPW determine the best use of these funds, we have deposited them in an interest bearing account that is currently accruing about \$1,000 annually. Susan Williams and Chris Glaeser have volunteered to lead a committee to explore the idea of using it as seed money for an Education Center. As Amazon Smile Goes Away a Better Idea with King Soopers

For those of you who use Amazon Smile it is going to be discontinued. If you had Friends of Castlewood Canyon listed as the charity attached to your purchases, you might want to think about using the King Soopers Community Rewards Program instead.

Kroger affiliates, King Soopers and City Market have a Community Rewards Program that lets customers support their favorite 501(c)(3) non profit with almost every grocery purchase. It's easy to set up just follow the instructions.

Once logged into your King Soopers or City Market account, you can search non profit, then click "Enroll".

New users will need to create an account which requires some basic information, a valid email address and a loyalty card. If you do not have a loyalty card, they are available at the customer service desk at any Kings Soopers or City Market.

In 2022, Friends of Castlewood Canyon received \$329.19 from King Soopers vs \$83.83 from Amazon Smile.

Thanks to Grant, Inner Canyon Stairs Will Be Rebuilt

ExtremeTerrain an online aftermarket parts retailer based in Paoli, PA. granted Friends \$250 via their **Clean Trail Initiative** -- a program they run year-round to support responsible land use. They offer grants to both outdoor (non-motorized) and off-road organizations to help with the costs associated with maintaining the land. Since the program started in 2015, they've donated over \$50,000 to trail maintenance and improvement projects across the U.S.

When we learned about this opportunity we asked Jordan how this might help Castlewood Canyon. He quickly replied he could rebuild the weird sideways stair sets on Inner Canyon. The \$250 would just about cover all of the cost of materials. So we applied for the grant and we got it. We can look forward to new stairs this spring thanks to ExtremeTerrain.
